

Agreed Summary of the 3 Foreign Ministers' Meeting on 9 May 2011 in Jakarta

AGREED SUMMARY

Meeting of the Deputy Prime Minister, Minister for Foreign Affairs and International Cooperation of Cambodia, H.E. Hun Sen; the Minister of Foreign Affairs of the Kingdom of Thailand, H.E. Kaiti Pongpa, and the Minister of Foreign Affairs of the Republic of Indonesia, H.E. S.H. Martyo Nugroho in Jakarta on 9 May 2011

1. As a follow-up to the meeting of the Prime Minister of the Kingdom of Cambodia, H.E. Norodom Hun Sen, the Prime Minister of the Kingdom of Thailand, H.E. Abhisit Vejjajiva, and the President of the Republic of Indonesia, H.E. Susilo Bambang Yudhoyono, the Deputy Prime Minister, Minister for Foreign Affairs and International Cooperation of Cambodia, H.E. Kaiti Pongpa, the Minister of Foreign Affairs of the Kingdom of Thailand, H.E. Kaiti Pongpa, and the Minister of Foreign Affairs of the Republic of Indonesia, H.E. S.H. Martyo Nugroho, met in Jakarta, on 9 May 2011.
2. Following the discussion, they reaffirm the Statement of the Chair of ASEAN following the Informal Meeting of the Foreign Ministers of ASEAN on 22 February 2011 and the Chairman Statement of the 17th ASEAN Summit in Nov 2011, as follows:

"We emphasized the underlying norm and principle of ASEAN that differences between ASEAN Member States should be amicably resolved in the spirit of ASEAN Guidelines, in accordance with the principles contained in the Treaty of Amity and Cooperation in Southeast Asia (TAC) and the ASEAN Charter.

We welcomed Cambodia's and Thailand's commitment to peacefully resolve their differences through mutual dialogue and cooperation with a view to achieving mutually acceptable solution through the Amity settlement of their existing bilateral mechanism, with cooperation engagement of Indonesia, current Chair of ASEAN. In this regard, we appreciate that Cambodia and Thailand have agreed on the text of the Terms of Reference (TOR) on the Indonesian-Governor Team (IGT) in the affected areas following the incident in February 2011 and encourage the attainment of an agreement conductor to their agreement. We also expressed our appreciation and support for the continuing effort of Indonesia, current Chair of ASEAN, to facilitate the process through its appropriate engagement which would help advance our collective efforts to attain the ASEAN Community."

3. In pursuance of the above, and in accordance with the task set by the Leaders in their aforementioned meeting on 8 May 2011, the Foreign Ministers concurred on a package of solutions, with appropriate timeline, as below:

- Exchange of letter on IGT TOR
 - Announcement of GRC/IBC Meetings
Timeline: "D"

 - Meetings of the GRC/IBC

 - Follow-up on results of GRC/IBC
Timeline: "D + 10"

4. The Foreign Ministers agreed to positively recommend the above package of solutions to their respective Governments for their early approval.
