AGREEMENT
BETWEEN
THE KINGDOM OF CAMBODIA AND THE KINGDOM OF THAILAND
ON
COMPLIANCE WITH THE ORDER OF 16 JULY 2011
OF THE INTERNATIONAL COURT OF JUSTICE

In compliance with Paragraph 10 of Order 22/13/10 July (Case No. 1) (hereinafter the "Order") of the International Court of Justice (hereinafter the "ICJ"), the Royal Government of Cambodia and the Government of the Kingdom of Thailand (hereinafter referred to as the "Parties") have, in accordance with the Charter of the Association of Southeast Asian Nations (hereinafter the "ASEAN"), entered into the following:

1. With a view to implementing the immediate withdrawal of all military personnel from the Preah Vihear area, the Parties, in accordance with Paragraph 10 of the Order, and in cooperation with the Indonesian Observer Team, shall inform the Secretary-General of the ICJ of the military personnel and their positions, as of 15 July 2011, within the PVE.

2. With a view to ensuring Cambodia's free access to the Temple of Preah Vihear and to ensure normal abatement to water in the PVE, and in cooperation with Indonesia, the Parties shall, in accordance with Paragraph 10 of the Order, take all necessary measures to ensure the free flow of water in the PVE.

3. After the entry into force of this Agreement, both Parties request the speedy settlement and dismissal of the Indonesian Observer Team, as stated in Paragraph 10 of the Order, and in accordance with Paragraph 10 of the Order by the Secretary-General of the ICJ.

4. Once the Indonesian Observer Team are in place, the Parties shall cooperate with the Indonesian Observer Team to determine the status of Preah A, B, C, and D of the PVE in accordance with the conditions specified in Paragraph 10 of the Order.

5. Both Parties, in cooperation with the Indonesian Observer, shall draw up a schedule for the immediate withdrawal of all force except water provisions from the PVE.

6. In accordance with Paragraph 10 of the Order, this Agreement shall not prejudice the status of the ICJ and ICJ shall not be responsible for the border and water security and other in the border.

7. The settlement of claims, compensation and financial claims for the Indonesian Observer Team and responsibilities of Cambodia and Thailand in following the status of the Indonesian Observer Team shall be defined in a separate agreement to be signed between Cambodia, Thailand and Indonesia, in accordance with Paragraph 10 of the Order and Court.

This Agreement will come into effect on the date of signature.
